
ENVIRONMENT AND GREEN CAMPUS POLICY DOCUMENT

The college has a bore well to handle the institution's basic needs. Through a system of well-connected pipes, the water from the roof tops and the rainwater are combined and collected. This set up is useful for gathering water, which is then gathered into trenches made specifically for this use. The campus's greenery is maintained with the help of the rainwater collected in the pits. The nearby bore wells are recharged and the ground water level rises during the hot summer months when water scarcity is greater.

Policy Document
